**Participation Agreement, Release of Liability and Waiver**

I, \_\_\_\_\_, certify that I am a retired officer of the Illinois State Police, who is eligible to attempt to qualify to carry a concealed firearm, pursuant to the Law Enforcement Officer Safety Act of 2004 (18 U.S.C. 926B). I understand that in order to qualify, I will be required to fire my weapon under the direct supervision and direction of an Illinois State Police Range Officer and in accordance with the COVID-19 (coronavirus) guidelines listed below.

In consideration of the ISP allowing me access to and use of the Illinois State Police range facilities, I, for myself and on behalf of my heirs, to the fullest extent allowed by law, hereby agree to indemnify, release, and hold harmless the State of Illinois, the Illinois State Police, and all of their respective agents and employees, for any and all claims and causes of action including those involving any COVID-19 related health issues, arising in whole or in part from my participation in the qualification process.

I understand that in 2020 the World Health Organization declared the spread of COVID-19 (coronavirus) a pandemic, and Illinois Governor Pritzker issued a disaster proclamation for the state due to the spread of COVID-19. As a result, ISP instituted the following guidelines which I agree to follow in order to participate in the qualification process:

- 1) All participants will be required to wear a procedural mask at all times while on ISP property. (ISP will issue the procedural mask.) (Cloth masks will NOT be permitted.)
- 3) All participants will be required to wear eye protection. (Range glasses are acceptable.)
- 4) No congregating will be permitted anywhere in or on ISP facilities.
- 5) All participants will be required to maintain six foot social distancing at all times when practicable.
- 6) No sharing of weapons or equipment will be permitted.
- 7) Participants must sanitize hands before and after any contact with another individual, with a weapon, or with equipment.
- 8) Hand sanitization will be required upon entering the range and upon leaving the range.
- 9) A maximum of 6 shooters will be permitted on the range at any single time.

I understand and agree the above listed guidelines are in addition to the ones required in ISP Directive ORD-002, including qualifications of retired or separated officers. (Para. IV.D.)
